## Financial Results Update, Appendix 3B and Appendix 3Y

---

**OBJ Limited (ASX: OBJ)** advises that as announced to the market on 30 August 2017, the shares subject to Tranche 2 Performance Rights will not be issued notwithstanding satisfaction of the associated milestone. Accordingly, the Company has reversed an amount of \$2,492,668 against Consultant and Salary Expenses which represents all of the expense that has been recognised since grant date in relation to these Tranche 2 Performance Rights. The resultant net loss for the year ended 30 June 2017 will be \$3,044,208 and not \$5,536,876 as reported in the Appendix 4E lodged with the ASX on 22 August 2017.

This will also be reflected in the Company's forthcoming Annual Report.

The Company also announces Appendix 3B and Appendix 3Y disclosures in relation to Milestone 1.


